



## INDIVIDUAL AGREEMENT FOR ACCESS AND USE OF DATA

I have read and understood the following statement:

*All materials provided by RODA are protected by copyright and intellectual property rights. Multiplication and/or sale of part or all of the data set are prohibited. The exception is when the multiplication is done in the interest of research or educational purposes. For any other use permission must be obtained from RODA or from the depositor. Copies (electronic or printed) can not be given with the purpose of sale to other persons who are not authorized users without permission RODA or depozitorului.*

In addition, with respect to any material that is offered by RODA I commit myself:

1. To use and multiply data sets or parts of it only for research or teaching.
2. To allow access to the data set, in part or in whole, or to any material made on this basis, only to registered users who have the permission from RODA to use it. Exceptions are data sets required for teaching objectives, based on a **Teaching Access Agreement** signed by students.
3. **To respect any conditions that are presented in on-screen instructions or in any other form, related to accessing data sets or using related materials.**
4. Always keep the confidentiality of information that may lead to the identification of subjects and/or registered households data sets. In addition, where appropriate, to keep the confidentiality of information offered by different organizations in registered data sets. In particular, I undertake not to use or attempt to use data sets for the purposes of deliberate compromise of subjects, households or organizations, thus respecting professional ontology of social data manipulation.
5. To pay the cost of materials and operation for research and teaching activities. In specific cases, the payments for the data set are charged by RODA taking into consideration the depositor's requirements.
6. That personal data that I recorded are genuine and that any changes in personal data, especially those related to employment status, will be updated in the personal space on the website of the RODA in the shortest time possible.



I understand that violation of any of the above points of this commitment may result in immediate termination of my access to all services offered by RODA, either permanently or temporarily, depending on RODA 's decision and can result in legal proceedings.

I agree:

1. To remember in any publication (print, electronic or radio transmitting/TV), based in part or entirely on collections of data used by the manufacturer data, who owns the copyright of data collection, the funders of data sets and RODA. Where necessary, to quote the data set used, using citation rules accompanying documentation data collection.
2. To remember in any publication (broadcast printed, electronic or broadcast radio/TV), based in whole or in part on data collections, that the original producers of the data, those who own copyrights, the funders of data collection bear no responsibility for analysis and/or subsequent interpretation of data.
3. To send RODA two copies (an electronic and a printed format) of any publication based wholly or partly on set (sets) of data that we used. I agree to make available additional information, if necessary.
4. That RODA can keep my personal data registered in the Registration Form for statistical purposes, validation and record invoices and may transmit such personal data to the depositor's data and/or to the owner of the data set. I can ask the copies of data that RODA holds about me and the names of persons and/or institutions that have received this information.
5. To let RODA know about any errors discovered in the data set.
6. To accept that RODA may collect certain fees on Database distribution or any other service provided by Roda and that these fees are subject to change and these changes will begin to be available within 30 days of the date when they were made public by persons registered or database users.
7. As a conclusion of my research or any time at the request of the Director of RODA to offer for storage in the archive, through appropriate means and at my expense any new data sets arose from the RODA materials or materials that have been created by the combination of RODA data and other data. Storing the derived data set will include a detailed documentation so that the information derived can be used by others.
8. To accept that RODA, producers of data, people or institutions that hold copyright, or funders of database bear no legal responsibility on the degree of accuracy or intelligibility and that RODA, data producers, individuals or institutions that have the right of copyright or sponsors can not be held liable for incidental or consequential

loss or damage arising from the use of data sets.

9. That RODA can, even if there is no defect, cancel the contract or change its terms after a notice of 30 days or at the end of a service for which the user has paid in advance, whichever is the longer period.
